- (f) The Trading Terms are a "Security Agreement" (as defined in the *Personal Property Securities Act 2009 (Cth)*) ("**PPSA**") and the Applicant grants the Company a "security interest" (as defined in the PPSA) in respect to all Goods present or future that are supplied to the Applicant from time to time and in any property that represents "Proceeds", "Accessions", "Processed" and "Comingled" goods (all as defined in the PPSA)) that are in any way connected to or related to the Goods .
- (g) The Company may register on the PPS Register its security interest in all Goods that the Company supplies to the Applicant on a retention of title basis.

The Signatory to this Application represents and warrants that:

- (a) The information provided in this Application Form is true and correct and is not misleading;
- (b) The information provided herein may be relied upon by the Company to determine whether to grant the Applicant credit and/or to supply Goods to them and
- (c) He/she has full authority to complete this Application on behalf of the Applicant.
